VACANCIES ON CITY BOARDS/COMMITTEES

WHITEFISH LAKE & LAKESHORE PROTECTION COMMITTEE

One (1) position, term ending December 31, 2019, applicant shall reside within the corporate limits of the City of Whitefish; The Committee meets on the 2nd Wednesday in the evening.

BOARD OF APPEALS – One position, term not designated. The Board of Appeals determines suitability of alternate materials and methods of construction and to provide for reasonable interpretations of the International Building Code. Applicant must be qualified by experience or training to pass on matters pertaining to building construction. The Committee meets as needed.

BOARD OF ADJUSTMENT – One (1) position, complete term ending December 31, 2020. Applicant shall reside within the corporate city limits of Whitefish. The Committee meets as needed, the first Tuesday of the month at 6:00 pm.

WHITEFISH CONVENTION AND VISITOR BUREAU COMMITTEE – Four (4) positions, one (1) term ending May 31, 2020, representative of Transportation Business; three (3) positions open to residents of the City of Whitefish, or may be residents in Flathead County as long as member has an ownership interest or managerial position of Finance, Large Lodging Properties, Bar/Restaurant, Retail, Small Lodging, Whitefish Golf Course, or Whitefish Mountain Resort. Committee meets once every other month.

BOARD OF PARK COMMISSIONERS – Three (3) positions, 2-year term. Applicants must have resided within the city limits for 2 years and within the State for 3 years and must be at least 21 years old. The Committee meets on the 2nd Tuesday in the evening.

RESORT TAX MONITORING COMMITTEE – Two (2) positions, 3-year terms. Applicants can be an owner, operator or representative of any Bar/Restaurant, Lodging, Retail in the city limits of Whitefish; business owner at large in the city limits of Whitefish; or an interested city resident as a member-at-large. The Committee meets once a month in the morning.

POLICE COMMISSION – One (1) position, 3-year term. Applicant shall reside within city limits of Whitefish and maintain residency within the city for one year prior to appointment. Commission meets as needed.

ARCHITECTURAL REVIEW COMMITTEE – Three (3) positions, 3-year term. Applicant shall reside within city limits, are employed, own a business, or own property in city of Whitefish, or a Montana licensed architect, or licensed design professional. Committee meets as frequently as necessary.

HIGHWAY 93 SOUTH CORRIDOR PLAN STEERING COMMITTEE – One (1) position. Applicant shall be a residential owner-occupied property owner in or adjacent to the Highway 93 Corridor.
